 Subject: Request for Clarification and Compliance With Government Guidelines Regarding School Picnic Destinations
 Respected Sir/Madam, This letter is in reference to the MBMC communication No. जा क्र मनाप ज्ञाज्ञाण ७४२ / २०२५ -२६ dated 20/11/2025, and my grievance filed on the APPL E SARKAR portal (No. DIS/URDM/THAN/2025/3782 dated 08/11/2025). In your reply, it has been stated that school picnics in Mira-Bhayander—whether to museums, libraries, zoos, resorts, historical places, beaches, or theme parks—are decided by the school management after holding meetings with parents and students before finalizing the picnic location. While parental consultation is certainly important, I would respectfully like to seek clarification on the following points: Whether meetings with parents alone are sufficient grounds to picnic destinations such as beaches, resorts, or theme parks, considering that these locations may not always align with the core educational objectives of school excursions. Whether such destinations are supported or encouraged under the Government of Maharashtra's official guidelines, circulars, or directives relating to school educational tours. For your ready reference, I wish to draw attention to the relevant Government Circular: Circular No. Sankirn 2016 / Pr. Kr. 269 dated 20/05/2017, which outlines principles and guidelines regarding the planning of school educational trips. As per my understanding, the circular places emphasis on educational relevance, student safety, and the need for excursions to contribute meaningfully to the holistic development of students. In light of this, I request MBMC to kindly: Ensure that all school picnics are arranged strictly in accordance with the above-referred Government guidelines and any other directives issued by the Government of Maharashtra. Clarify whether the selection of resorts, beaches, and theme parks is permissible under current state guidelines, or whether any conditions, restrictions, or approvals apply to such destinations. Inform citizens, including parents and guardians, if there are any additional guidelines or circulars issued by the Maharashtra Government pertaining to school picnics at recreational or commercial venues. This clarification will help maintain transparency, ensure the safety and educational value of school outings, and protect the interests and development of all students.
