## **Express of Interest**

#### 1. Background Information:

In response to the burgeoning urbanization in Mira Bhayandar, the city's infrastructure is facing unprecedented strain. Recognizing the limitations of government agencies, Mira Bhayandar Municipal Corporation (MBMC) is actively addressing the sanitation infrastructure needs. In this regard, MBMC invites proposals from esteemed NGOs, Trusts, Foundations, Agencies, and qualified individuals, particularly from the Valmiki and Mehtar communities, for the operation andmaintenance of community toilets.

#### 2. Objective:

This Expression of Interest (EoI) cum Bid aims to empanel qualified and experienced entities to undertake the crucial task of maintaining community toilets within various locations across Mira Bhayandar. MBMC seeks expressions of interest from eligible NGOs, Trusts, Foundations, Agencies, and individuals, with a preference for those from the Valmiki and Mehtar communities, to contribute to the enhancement of sanitation services and community well-being.

#### 3. Scope of Work:

The scope of operation and maintenance involves 191 community toilets distributed across all six zones, as outlined in Annexure 1. Applicants are expected to tailor their proposals to address the unique challenges and opportunities presented by each zone.

#### 4. User Charges:

Presently, MBMC levies a charge of 60 Rupees per household for 5 members, with an additional Rs. 10 per member. Entities submitting proposals are required to provide their proposed rates for user charges, ensuring competitiveness, fairness, and sustainability. The proposed rates should promote accessibility for all residents within the region.

#### 5. Submission Guidelines:

Interested entities are required to submit comprehensive proposals, encompassing: Operational plan Financial breakdown, Relevant experience in similar projects, detailed strategy for user charge collection,Proposed rates for user charges. Organizations should underscore their commitment to maintaining high hygiene standards and engaging with the local community for effective collaboration.

#### 6. Contact Information:

For detailed guidelines and clarification of queries, interested entities can reach out to the Deputy Commissioner, Solid Waste Management Department, Mira Bhayandar Municipal Corporation. Contact information is available on the official MBMC website. Qualified entities are invited to actively participate in contributing to the collective goal of promoting sanitation, hygiene, and community welfare in Mira Bhayandar.

#### Terms & Conditions:

- 1. The agency is mandated to collect user charges for community toilets based on the conditions specified in the contract agreement with both the agency and the relevant authority of the Mira Bhayandar Municipal Corporation.
- 2. The Mira Bhayandar Municipal Corporation shall determine the operating hours of the community toilets.
- 3. The agency is responsible for bearing the costs associated with water consumption for washing and cleaning, as well as electricity charges.
- 4. The agency is obligated to maintain the aforementioned toilets for a period of one year, and maintenance charges, according to predefined rates, will be collected from users/households.
- 5. The Mira Bhayandar Municipal Corporation will grant a license for a duration of one year.
- 6. The agency will issue monthly passes, and necessary support systems will be provided by the Urban Local Body (ULB).
- 7. Prior to handover to the agency, all community toilets will undergo renovation by the ULB.
- 8. Old water and electricity bills will not be transferred to the new service provider agency.
- 9. Community Toilet Federation with experience in operating toilets in slum areas will be given preference.
- 10. The responsibility for caretaker rooms lies with the service provider agency.
- 11. The agency will conduct verification of total family members, and necessary documents will bescrutinized to meet expenses.
- 12. Monthly passes' samples must be approved by the Mira Bhayandar Municipal Corporation.
- 13. Incomplete toilets will not be handed over without water and light facilities.
- 14. Meter safety boxes will be arranged for safety purposes and to prevent misuse.
- 15. Day-to-day necessary operations will be jointly handled by the sanitary inspector and the service provider agency.
- 16. Uniform monthly passes will be provided, consisting of simple use of community toilets.
- 17. Water and electricity security will be the responsibility of MBMC, and legal penalties for misuse will be imposed on the concerned entity.
- 18. Necessary support, including the handover of community toilet blocks with basic amenities, will be ensured by MBMC.

- 19. Presently working workers/caretakers will be absorbed as sanitary workers under the terms and conditions of the service provider agency.
- 20. The Corporation will not have any influence in deciding on such workers.
- 21. In case the present caretaker does not vacate the place, MBMC will provide support to evacuate the room, which will then be handed over to the service provider agency for the new caretaker.
- 22. Any legal matters arising in such cases will not be handled by the service provider agency.
- 23. The service provider agency shall resume services once community toilets are ready for handover.
- 24. Joint inspections will be conducted before handing over the toilet block and then after proper order, the toilet will be handed over to the respective agency. Until that date, the old caretaker/SPA will continue the service.
- 25. As per the requirements of the Swachh Bharat Mission, the service providing agency shall provide necessary support and full cooperation for maintaining cleanliness in accordance with the guidelines of MBMC and SBM.
- 26. User registration shall be maintained by the agency and certified by the respective areasanitary inspector.

#### 7. Eligibility Criteria

- 1. Tender Form Fee (Rs. 590/-)
- 2. Earnest Money Deposit (Rs. 1000/-)
- 3. Goods and Services Tax Registration Certificate (GST Registration Certificate)
- 4. Copy of PAN Card (In case of company/partnership submitting the tender, it is mandatory to have PAN card in the name of the concerned company/partnership. In case of Proprietary works, PAN card in the name of the proprietor.)
- 5. The Applicant shall be a non-governmental organization (NGOs), Trusts, SHG, Foundations, Agencies, or qualified individuals, with a preference for those from the Valmiki and Mehtar communities persons, or an organization under the Companies Act or the relevant state Acts. Documentary evidence substantiating this status must be submitted along with the Proposal.
- 6. Registered office address with fax/ telephone no, e-mail ID of the Organization/ Person.

### Expression of Interest is hereby invited from reputed NGOs, Trusts, Foundations, Agencies, and qualified individuals, with a preference for those from the Valmiki and Mehtar communities, possessing the required experience to operate and maintain Community Toilets.

**License Period:** The selected agencies will be granted a license to operate the toilet complex site for a period of 01 (One) year. However, it is essential to note that the title of the land, including the structure built for Community toilet purposes with all fittings & fixtures will continue to remain with the Mira Bhayandar Municipal Corporation.

**Maintenance Duration**: The selected bidders shall be responsible for the maintenance of the toilets for a period of 01 (One) year.

**User Charges:** User charges will be collected from households and users. The charges per household per use will be Rs............ (Rupees) only for the pay and use of the toilet.

**Application Availability**: Details of the scheme, eligibility criteria, and the prescribed application format are outlined in the Expression of Interest (EOI) document. The EOI document can be obtained from the office of the Deputy Commissioner, Solid Waste Management Department, Mira Bhayandar Municipal Corporation, from 05/03/2024 to 11/03/2024.
